

## ARTICLE II: MEMBERSHIP

### Section 5: Junior Membership (See Attachment A)

Persons ~~sixteen (16)~~ or fourteen (14) thru seventeen (17) years of age can only be accepted as Junior members. Junior members shall enjoy all the privileges and responsibilities of other members with certain exceptions because of their age. Written permission must accompany their applications signed by either their parent or guardian, giving consent to participate in the Fire Company activities, along with the required dues payment.

Junior members must reside in East Hanover Township, Dauphin County. Application from outside of the area is subject to approval by majority consent of the Fire Board.

Application for Junior membership must be accompanied by a copy of Pennsylvania State working papers issued to the applicant.

## ATTACHMENT A JUNIOR MEMBERSHIP

### *General*

All records were very accurate.



**My Incident Reports:** All reports entered and submitted to the state


**Knox Box Key Holders:** Every emergency responder's personal codes have been entered into each key holder. As a reminder the personal code is 39[last 4 of SSN]#.
